POLICE CHIEF JON MAPLES presented a proposed police officer recruitment and retention program to be implemented in the Police Department. Chief Maples is proposing that a program be implemented where the city pay for the Police Academy in return for an employee to sign an employment contract committing to work for the City for so many years or reimburse the City for the Academy costs, similar to the Fire Department. Chief Maples also proposed a \$4,000 training reimbursement for current POST certified officers for their academy costs. Council requested more time to consider the proposed recruitment program and asked the attorney to look into the legality of the reimbursement of current officers.

CITY ADMINISTRATOR DARIN CHAPPELL presented discussion requesting the Council temporarily suspend the cap on the vacation carry over policy because of staffing issues/shortages during the past year. Employees didn't have the opportunity to use their vacation and because of the cap they are losing their earned vacation time. MOTION BY COUNCILMAN FOSDICK second by Councilman Cunningham to temporarily lift the cap on

the vacation carry over policy. Motion passed with a vote of four yeas: Councilman Ashbrook absent; Councilman Dupy voted yea; Councilman Cunningham voted yea; Councilman Fosdick voted yea; Councilman Jarding voted yea.

ROBERT COWHERD, City Attorney, presented the Council with a donation of 35 acres from the Jenkins Foundation located on the south side of 36 highway.
