Motion passed with a vote of four yeas: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea; Councilman Fosdick absent; Councilwoman Jarding voted yea.

Discussion was also held regarding the zoning of the land for the proposed senior housing development. According to the City Attorney the property is not currently zoned properly to allow for such development and would need to be changed to either R3 or MU. This will be brought back to the council at a later date.

DARIN CHAPPELL, City Administrator, presented Discussion regarding Ordinance 2021-54 regarding cargo containers. The ordinance excludes commercial districts to have cargo containers yet several businesses in the commercial zone currently have such containers. It was recommended that perhaps the ordinance be amended to regulate cargo containers only in residential areas. Lengthy discussion was held regarding cargo container regulations in all districts without resolution. Proposed amendments will be brought back at the next meeting. It was the consensus of the City Council for existing businesses to continue to have cargo containers and allow for additional containers to be brought in for the holiday season if need be.

DARIN CHAPPELL, City Administrator, presented discussion and request from the Bird Company to consider having Bird scooters in Chillicothe and entering into a Memorandum of Understanding. No action was taken, Council directed Darin Chappell to get more information regarding rules and regulations of these scooters.
