MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the previous minutes from June 26, 2023. Motion passed with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the invoices for July 10, 2023, in the amount of \$436,817.92. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- noted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the payroll for June 23, 2023, in the amount of \$192,797.19. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilwoman Soper to approve the CMU Invoices and salaries in the amount of \$371,785.00 (includes \$94,231.13 in salaries) from the July 5, 2023, Board Meeting. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilwoman Soper to approve **Ordinance # 2023-69** approving the final plat of the Fairway Meadows subdivision. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea. Matt Jacobs and Ian Wright, engineers with Lochner, made a presentation on the new Self-fueling system that will be installed at the Chillicothe Municipal Airport. He explained that they will go out to bid on July 25, 2023, and will publicly open the bids on Tuesday August 22, 2023. It will then be presented at the City Council meeting currently scheduled for September 14, 2023. They gave a rough estimate of \$845,000. With the Federal Funding for this program the City will be responsible for approximately \$50,000 - \$60,000, which is a 90/10 split of the total cost. The estimated date of completion is approximately 1 year.

Councilman Wayne Cunningham has requested to be replaced on the Historic Preservation Commission (HPC). The mayor would like to appoint Councilman Reed Dupy to take his place. This position is to be held by a council ex-officio member (non-voting member) therefore there was no application process. MOTION BY COUNCILMAN ASHBROOK, second by Councilman Cunningham to approve the appointment of Councilman Reed Dupy to the HPC. Motion passes with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy - abstained; Councilman Cunningham voted yea by Webex; Councilwoman Soper- noted yea, and Councilwoman Jarding voted yea.

- 1. Mayor received word that past City Administrator John Edwards has passed away, and 8 days later his 68-year-old son passed away. Our thoughts and prayers are with the Edwards family at this difficult time.
- 2. The past weekend in Chillicothe was full of Life and Fun. Started with breakfast at LivCo Vet building, followed by the Sliced Bread Day Parade, Veteran's Ballgame and many more activities.

- 4. This coming weekend is the annual Car Show and Friday night will be the City's display of Fireworks (rain day is Saturday July 15th),

COMMENTS FROM THE COUNCIL:

- Councilman Tom Ashbrook Commended CMU for their help at the Greenhills Golf Course and getting the pump up and running at a fraction of the cost of replacing it. He would like Allison to keep track of this and the golf course needs to reimburse CMU for their time.
- Councilman Reed Dupy He rode with Chief Reeter to pickup the new ambulances last Thursday. He had the pleasure of being able to drive one of the ambulances to Chillicothe. One of the ambulances was even in the parade Saturday. The ambulances are not in use yet as they are scheduled to have their radios installed next week.

- 4. Councilman Stacey Soper New Ambulances are Hot. The new gurney system works great and should save a lot of backs and hips.
