MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the invoices for July 31, 2023, in the amount of \$324,275.16. Motion passes with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham – absent not yet joined by Webex; Councilwoman Soper- noted yea, and Councilwoman Jarding voted yea.

Third Ward Councilman Wayne Cunningham joined by Webex.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the payroll for July 7, 2023, in the amount of \$216,044.06. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the payroll for July 21, 2023, in the amount of \$210,258.65. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the CMU Invoices and salaries in the amount of \$1,089,744.23 (includes \$100,139.62 in salaries) from the July 25, 2023, Board Meeting. Motion passes with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – abstained, and Councilwoman Jarding voted yea. City Administrator said that the item of the Chillicothe RII school District would be next on the agenda because of a time issue with Principal Dan Nagle. The school district is requesting that the city install a stop sign (North and South bound) at the second entrance of the High School off Hornet Drive. Principal Nagle said that during the school year when students are leaving the 3rd entrance and headed south bound it gets congested and the buses cannot pull out on to Hornet Drive. The school is willing to share this cost. Street Superintendent Jeff Gillispie said that they had the signs already on hand. The board agreed that stop signs could be put there but it would have to be approved by an ordinance at the next meeting on August 14, 2023.

MOTION BY COUNCILMAN DUPY, second by Councilman Ashbrook to approve **Ordinance # 2023-70** accepting a grant agreement with the Missouri Department of Economic Development for Industrial Site Development purposes for State American Rescue Plan Act funds and all acts necessary for such grant. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve **Ordinance # 2023-71** authorizing an agreement addendum with Allgeier Martin & Associates for engineering services and authorizing all acts necessary to carry out the terms of such contract, to perform a stormwater study between Clay and Ann streets and Washington and Locusts streets. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve **Ordinance # 2023-72** accepting the purchase agreement for a Life Scan (finger printing machine) from IDEMIA to be used by the Chillicothe Police Department. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve 1/3 of the payment (not to exceed \$4,000) of the applicants cost for a survey to expand the Historic/Industrial District, and as long as the county and CDC pay their portion. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper – voted yea, and Councilwoman Jarding voted yea.
