MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the payroll for May 26, 2023, in the amount of \$165,851.59. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea; Councilwoman Soper voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the CMU Invoices and salaries in the amount of \$1,060,512.98 (includes \$103,787.61 in salaries) from the June 6, 2023, Board Meeting. Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea; Councilwoman Soper voted yea, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN CUNNINGHAM, second by Councilman Ashbrook to approve **Ordinance 2023-64**, an ordinance of the City of Chillicothe, Missouri accepting the results of a Special Run-off Election and declaring Winner for the June 6, 2023, Special Run-off Election. (Reed Dupy with 230 votes). Motion passes with a vote of 5-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea; Councilwoman Soper voted yea, and Councilwoman Jarding voted yea.

Bryan Minnis spoke about the problem with were having with their irrigation pump at the Green Hills Golf Course. They received a quote of \$44,031.68 to replace the filter. 2nd Ward

Councilman Cunningham was concerned about them pumping from the well to the pond, and then from the pond to the irrigation system. It was decided that Matt Hopper and Chris Bonderer with CMU would work with Dexter pump and Bryan Minnis on determining whether buying this new filter was the best option or not. So, on contingency that that is the best option then the council approved to move forward, as it will take approximately 3 weeks to get the new filter and parts.

MOTION BY COUNCILMAN ASHBROOK, second by Councilwoman Soper to approve **Ordinance 2023-65**, an ordinance accepting bid on behalf of the Municipal Utilities Department for the purchase of a caterpillar 416-07 Backhoe with the extended warranty from Foley Equipment company through Sourcewell Purchasing Cooperative and authorizing all acts necessary to make such purchases. Motion passes with a roll call vote of 4-1: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted nay; Councilwoman Soper voted yea, and Councilwoman Jarding voted yea.
