Motion passed with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper- Absent, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the invoices for June 26, 2023, in the amount of \$352,366.65. MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the CMU Invoices and salaries in the amount of \$854,572.55 (includes \$98,572.55 in salaries) from the June 20, 2023, Board Meeting. Mayor Theresa Kelly made a recommendation to the council to appoint Cinthia Barnes to the Board of Adjustments and the Planning and Zoning Board to finish the unexpired terms of Ben White who resigned from the boards. The term for Board of Adjustment will expire on June 13, 2024, and the Planning and Zoning term will expire on January 30, 2024. MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve the appointment of Cinthia Barnes to the Board of Adjustments and the Planning and Zoning Board. MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to increase the starting wage of newly hired E911 Dispatchers to \$17.00 and hour and a \$.50 increase after they have successfully completed the MULES training. The same increase spread will be given to the current employees, effective immediately. Motion passes with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper - Absent, and Councilwoman Jarding voted yea.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve **Ordinance 2023-66**, an ordinance authorizing a construction services agreement with Monty Campbell in regard to removal of the Muddy Creek Railroad Bridge and all acts necessary to carry out the terms of such agreement. Motion passes with a vote of 4-0: Councilman Ashbrook voted yea; Councilman Dupy voted yea; Councilman Cunningham voted yea by Webex; Councilwoman Soper - Absent, and Councilwoman Jarding voted yea.

Jerry Norman spoke to the council about some concerns of the Muddy Creek Railroad Bridge and asked for an easement. City Attorney Robert Cowherd explained that the city could not issue an easement, but we could issue him a license/permit to get to his property at this time. City Clerk Amy Hess will get that license/permit ready and contact Mr. Jerry Norman when it is ready.

MOTION BY COUNCILMAN ASHBROOK, second by Councilman Dupy to approve **Ordinance 2023-67**, an ordinance accepting the lowest responsible bid for 423 Second Street demolition and residential building asbestos removal in Chillicothe, Missouri for \$8,975.00.
