## CHILLICOTHE PARKS AND RECREATION CHILLI BAY WATER PARK RESERVATION CONTRACT

This agreement is for a facility reservation within the designated property, Chilli Bay Water Park, of the City of Chillicothe, Missouri, under the operation of the Chillicothe Parks and Recreation Department.

Upon signing and returning this Agreement, the accompanying reservation form, and submitting a non-refundable\* payment in advance, Chilli Bay Water Park (CBWP) will reserve use of the designated area. This agreement does not become effective until full payment is received. Reservations are booked based on a first-come, first-serve basis.

The following rules and regulations must be obeyed.

- 1. No Alcohol permitted on site. (no exceptions)
- 2. No Smoking, Vaping, or Tobacco use on site. Designated areas only.
- 3. Lose trash shall be properly disposed of in trash receptacles.
- 4. Attendees must maintain proper conduct in a public setting.
- 5. All decorations (balloons, signs, etc...) must be removed at the conclusion of the reservation period.
- 6. All CBWP rules and regulations shall be obeyed.

In consideration for our use of facilities provided by the City of Chillicothe, Missouri, hereinafter referred to as "City", we hereby covenant and agree that the City, its employees, agents, volunteers, or independent contractors shall not be liable for any damages arising from personal injuries or damage to property which we may sustain in any way in, on, or about any property, real or personal, owned by the City before, after, or during any activity in which we are participating. Further, we will assume full responsibility for any such injuries or damages and do hereby fully and forever release and discharge the damages, rights of action, or causes of action, present or future, whether the same be known, anticipated, or unanticipated, resulting from, or arising out of, these activities. In the event that our actions should result in injuries to other persons or property and claim is made against the City, its employees, agents, volunteers, or independent contractors, we will hold harmless and defend and indemnify the City, its employees, agents, volunteers, and independent contracts against any claim, demand, damage, right of action, or cause of action, present or future, whether the same be known, anticipated, or unanticipated, resulting from our actions.

We also agree to pay for any damages to the premises or personal property owned by the City which was caused by our use or negligence, excluding normal wear and tear.

I have read and agree to all of the conditions of this Agreement and have signed of my own free act.
