| from any claim, cause of action, liability, loss, or ex | xpense (including court costs and attorney |
| fees) arising out of or because of the Contractor's p | erformance of his duties under this |
| Agreement, regardless of who makes the claim or w | whether the claim is based on the alleged |

intentional acts or negligence of the Contractor or his employees, agents or subcontractors.

Contractor will defend all actions at its own expense, including attorney's fees, and will satisfy any judgment rendered against the City in any such action; provided the City reserves the right to choose the attorneys defending the action. The Contractor will maintain in force a policy of public liability insurance covering Contractor's activities under this Contract in the amount of \$1,000,000, and will maintain an automotive liability policy (or underlying policy and umbrella policy) with single liability limits of \$1,000,000 on any vehicle used to carry out his services under this Contract, with the City named as an additional insured on each such policy. The Contract shall provide proof on insurance to the City on request.

If required by state law, the Contractor will maintain worker's compensation insurance.

- 6. Independent Contractor. Contractor understands and agrees that he is not an agent, servant or employee of the City and is acting as an independent contractor in performance of this Agreement. Contractor accepts and agrees to perform such services subject to the general supervision and direction of the City, particularly the City Code Enforcement Officer, and the City Administrator. As an independent contractor, the Contractor understands and agrees that none of the benefits provided by the City to its employees, including, but not limited to, worker's compensation, health and unemployment insurance, or retirement benefits are available from the City to the Contractor.
- 7. Tax Liability. Contractor will be solely responsible for any and all liability for state or federal income tax or other tax liability on the compensation paid, and for any and all payment due his employees or subcontractors including withholdings, benefits or contributions. The Contractor will hold the City harmless from any and all liability for such taxes or employee or subcontractor payments.
- 8. <u>Termination</u>. It is agreed by the parties that the City shall have the right to terminate this Agreement upon 30 days prior notice either verbally or in writing, to the Contractor, if the City, in its sole discretion, determines that Contractor's work is not efficient, conscientious, productive, and thorough. The Contractor may terminate the contract at any time upon 30 days prior written notice delivered to the City Administrator.

- 9. <u>Assignment.</u> The Contractor may not assign this Agreement. The Contractor may only subcontract any duties under this Agreement with the express prior written consent of the City.
- 10. <u>Binding Effect.</u> This Agreement is binding on the heirs, personal representatives, successors and assigns of the parties.
