

## NOTICE TO CONTRACTORS

and endorsed "Proposal" for construction of **2022 Street Rehabilitation – Phase 2** will be received by the City Clerk's Office in the City of Chillicothe, 715 Washington St., Chillicothe, Missouri 64601 until **11:00 AM, February 17th, 2022 Local Time**, at which the sealed bids will be publicly opened and read aloud in the Council Chambers.

### The proposed work includes the following streets:

**Irving Avenue:** Work generally consists of the reconstruction of approximately 260 linear feet of Irving Avenue including reconstruction of driveways. Estimated quantities consist of approximately 347 CY of excavation, 94 CY of embankment in place, 845 SY of aggregate base, 757 SY of 10-inch thick concrete pavement, 533 linear feet of concrete curb and gutter, 114 SY of concrete driveways, and installation of concrete sidewalk/ramps, including work zone traffic management, and erosion control.

**Olive Street:** Work generally consists of the reconstruction of approximately 605 linear feet of Olive Street including reconstruction of driveways and additional stormwater improvements. Estimated quantities consist of approximately 198 CY of excavation, 46 CY of embankment in place, 2,297 SY of aggregate base, 2,089 SY of 10-inch thick concrete pavement, 1,162 linear feet of concrete curb and gutter, 430 SY of concrete driveways, stormwater system, and installation of concrete sidewalk/ramps, including work zone traffic management, and erosion control.

**Woodrow Avenue:** Work generally consists of the reconstruction of approximately 1,089 linear feet of Woodrow Avenue including reconstruction of driveways and additional stormwater improvements. Estimated quantities consist of approximately 317 CY of excavation, 25 CY of embankment in place, 4,273 SY of aggregate base, 1,357 Tons of bituminous pavement, 415 SY of 10-inch thick concrete pavement, 2,182 linear feet of concrete curb and gutter, 208 SY of concrete driveways, stormwater system, and installation of concrete sidewalk/ramps, including work zone traffic management, and erosion control.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal.

Missouri law, 292.675 RSMO, requires the awarded Contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) Construction Safety Program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees.

**Enrollment in Federal Work Authorization Program:** Bidders are informed that pursuant to Section 285.530 RSMo as a condition of the award of any contract in excess of five thousand dollars (\$5000), the successful bidder shall, by sworn affidavit and provision of documentation, affirm its enrollment and documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection to the contracted services. Successful bidders shall also sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection to the contracted services.

The City of Chillicothe hereby notifies all bidders that it will affirmatively ensure that in any contract

entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
