ORDINANCE NO. 2021- 76

BILL NO. 2021- 80

An Ordinance of the City of Chillicothe, Missouri, Providing for New Ward Boundaries in the City of Chillicothe, Missouri and Repealing Ordinance No. 2011-100

WHEREAS, the City of Chillicothe is required to be divided into four (4) wards by its City Charter; and

WHEREAS, the residential development of the city since the last redistricting is concentrated in certain areas and has resulted in disproportionate representation of the citizens on the City Council of Chillicothe as shown by the 2020 decennial census; and


WHEREAS, the City Charter requires that the population of the four wards of the be established as near as practicable equal population in each ward; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CHILLICOTHE, MISSOURI, AS FOLLOWS:

- Section 1.** Ordinance No 2011-100 is hereby repealed.
- Section 2.** All previously existing wards within the City of Chillicothe are hereby eliminated and dissolved as separate wards, and the area previous contained therein shall be on and after the effective date of this Ordinance be contained within Wards 1,2,3, and 4 hereafter described in the attached Exhibit “A”, and entitled “City of Chillicothe Ward Map.”
- Section 3.** The attached City of Chillicothe Ward Map, labeled Exhibit “A” and incorporated herein, is hereby adopted and approved, and made a part of this Ordinance by reference hereof, and the Wards within the City of Chillicothe are hereby divided, designated and numbered as shown on said map.
- Section 4.** Wherever a Ward dividing line is shown as street, the dividing line shall be the center of such street.
- Section 5.** Except as provided in Section 4, any and all dividing lines shall be in conjunction with said property lines.
- Section 6.** All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
- Section 7.** If any clause, word, paragraph, section or other part or portion of this ordinance is held to be invalid, illegal, unlawful, or unconstitutional for any reason, the City Council hereby declares it would nevertheless have enacted the remaining portions thereof, and such remaining portions shall remain in full force and effect.

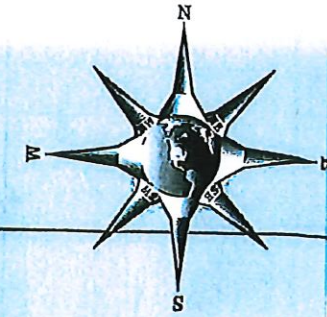
